
EPA EPD Grant Tip Sheet

The US Environmental Protection Agency (EPA) has announced a <u>program</u> to provide funding to enhance development of Environmental Product Declarations (EPDs).

What are key dates?



Who can apply?

Businesses incorporated in the US that manufacture construction materials and products and states, Indian Tribes, and nonprofit organizations that support such businesses.

Applicants may partner with other eligible entities and/or may serve as a pass-through for sub-grantees. One entity can be on multiple applications. The National Ready Mix Concrete Association (NRMCA) plans to apply as a subgrantor.

Consultants, management firms, architectural and engineering firms, information technology vendors, educational institutions and local government (city, county, etc.) are excluded from applying.

What is the grant size?

The grants will be evaluated in the following ranges:



If awarded a grant, NRMCA plans to offer smaller subgrants (~\$1k - \$5k) on a plant-by-plant basis.

How can the grant be used?

The projects must advance development or standardization of EPD. This includes

- Helping EPD transparency, reporting and analysis
- Improving EPD data quality, platforms and integration with databases like the federal <u>LCA Commons</u>
- Creating tools and resources for development and verification of EPDs
- Enhancing Product Category Rules

Projects must be based in the US and funds cannot be used for physical construction.



How can you apply?

Federal Grant:

- Register with <u>SAM.gov</u> and create an account (this can take 7-10 business days)
- Create **Grants.gov** account
 - In Grants.gov search for the EPA EPD grant using the following Funding Opportunity Number: EPA-R-OCSPP-OPPT-FY2023-001
- Create a Workspace in Grants.gov to begin the application process
- Consult the EPA Application Guide to answer questions

What is required in the application?

The application will consist of many several documents and forms. The complete list is available in Section 4 of the Notice of Funding Opportunity. The two key documents are:

Project Narrative	15-page description of the work to be performed during grant performance period, plan for tracking and reporting on progress and anticipated results
Budget	Table showing entire cost, including reporting costs
