You start generating carbon credit data the moment you start using CarbonCure in your concrete production. When you sign up for our Carbon Credit Program and participate in a data exchange, our team starts the ball rolling on a process of carbon credit validation, certification, and eventual sale — resulting in a significant revenue share opportunity.

Cash In on Your Concrete Data

Concrete producers in our Carbon Credit Program are required to share historical and ongoing batching and ticketing data to determine the amount of CO₂ removals and reductions in each batch. The carbon credit value is derived from the amount of data we can gather to prove that carbon savings actually took place.

How We Use Your Data

CarbonCure has a highly automated system to ensure the accurate and credible generation of credits based on the data you provide.

Immutable Change Log

Any changes to any data, from batching and ticketing to credit transactions, are automatically logged and cannot be altered.

Note: In cases where changes are made based on updates to past producer data, new tickets are assigned to older credits until any impacted credit is guaranteed to account for 1 ton of CO₂.

Automated Credit Generation

Credit generation is an automatic process with limited human touch and limited outside access to our database.

Note: Credits can only be generated if producer batching data matches CO₂ injection data from our on-site telemetry, and telemetry data is automatically transmitted to our database without intervention. Once a ticket is assigned to a credit, it will not be undone.

Audit Opportunities

Our process is easily auditable, and Verra has examined our data when certifying credits to ensure accuracy.

Note: We welcome any audits and are always seeking ways to make the process more transparent and streamlined.

Our Robust Verification Process

CarbonCure, in partnership with Verra, has developed a robust methodology (VM0043) to validate the carbon credits generated through your use of our technology.

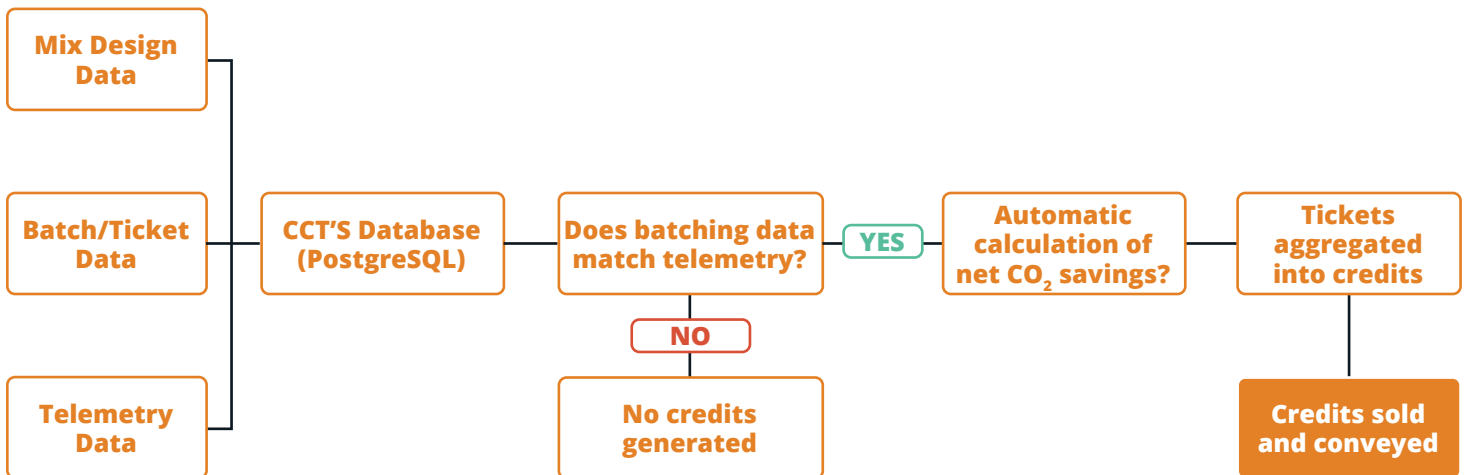
This methodology ensures the credibility of our carbon credit generation by incorporating data from various stages of the concrete production process. Verra's validation adds a crucial layer of authenticity to our carbon credit claims. With Verra's seal of approval, carbon credit buyers can trust the accuracy and integrity of our carbon capture and removal data.

Carbon Credit Eligibility Checklist

- ✓ Must be a ready mix concrete producer injecting CO₂ via CarbonCure
- ✓ Must show cement reduction with CO₂ versus the same mix without CO₂
- ✓ Concrete performance must be maintained compared to the baseline
- ✓ Concrete must be sold and used commercially (for any application)
- ✓ No additional credits can be generated from the use of SCMs
- ✓ CO₂ must be sourced from where it would have otherwise been emitted
- ✓ Only CO₂ emissions are considered in this program (no other GHGs)
- ✓ Data collected as part of the process must be archived for 2 years minimum
